



We thankfully and prayerfully observe the decline in the National and PHC Daily Covid 19 Census. November 16— we chart for the first time the National Census which went down to less than 1,000 cases per day; and November 17, 2021 marked the first time in months that we had "0" ZERO HCW admitted.

Indeed we rejoice and yet continue to enjoin everyone to remain vigilant and be practicing the minimum health protocols, even as the mandatory use of faceshields have been lifted in areas under Level 1 to 3 which President Rodrigo Roa Duter approved upon recommendation of the Inter-Agency Task Force.

PUBLIC ADVISORY ON COVID-19 BOOSTER SHOTS

15 November 2021

All fully-vaccinated healthcare workers may avail of booster doses starting 17 November 2021 (Wednesday). Based on the Emergency Use Authorization (EUA) issued by the FDA, the DOH recommends using either Moderna, Pfizer, and Sinovac as booster doses regardless of the brand used for the primary series. Sinovac will also be offered as a booster for those that had Sinovac as primary series.

Guidelines will be released on 16 November 2021 by the National Vaccine Operations Center (NVOC).
